

SPECIAL TERMS AND CONDITIONS ON ISSUING AND USING DINERS CLUB LOYALTY CARD ISSUED BY ERSTE CARD CLUB d.o.o.

1. These Special Terms and Conditions on Issuing and Using Diners Club Loyalty Card Issued by Erste Card Club d.o.o. (hereinafter: "the Special Terms") set special terms and conditions and fees for issuing and using Diners Club Loyalty Card (hereinafter: DC Loyalty Card).
2. Terms with a capital initial letter have the meaning as defined under the General General Terms of the Blanket Agreement on Issuing and Using the Diners Club Card Issued by Erste Card Club d.o.o. (hereinafter: "the General Terms"), unless otherwise specified in these Special Terms.
3. ECC grants DC Loyalty carda to users of Diners Club cards who take part in "dinersirano za vas" award programme, who act as a Consumer (hereinafter: User).
4. DC Loyalty Card is linked to one valid Basic, Additional Diners Club Card, Diners Club Junior Card or Diners Club Rijeka City Card companion card. In case the Basic Diners Club Card, to which DC Loyalty Card is linked to, ceases to be valid for any reason, DC Loyalty Card is linked to the next valid Basic Diners Club Card issued to the User and so on, provided that the respective card participates in the "dinersirano za vas" award programme.
5. Basic functionalities of DC Loyalty Card include one-time purchases of goods and services at Points of Sale in the Republic of Croatia.
6. The User can pay with his/hers DC Loyalty Card at a Point of Sale, if the expenses do not exceed 300% of the amount of available loyalty points on DC Loyalty Card at the time of payment. Maximum amount that can be spent on a DC Loyalty Card, in excess of the number of available loyalty points at the time of payment made with DC Loyalty Card at a Point of Sale, amounts to 2,000 Kuna.
7. Pursuant to Article 6 of the Special Terms, the User agrees that the cost charged to DC Loyalty Card at a Point of Sale in excess of the number of available loyalty points shall be recorded as cost on the Card to which DC Loyalty Card has been linked to, and undertakes to settle such cost timely and fully.
8. If the Card, to which DC Loyalty Cards is linked, has been blocked in accordance with the General Terms, ECC will block the use of DC Loyalty Card as long as the card is blocked to which DC Loyalty Card is linked too. In such cases, utilization of loyalty points remaining on DC Loyalty Card will be possible after the Card to which DC Loyalty Card is linked to has been unblocked.
9. ECC issues the specification of payment transactions on DC Loyalty Card to Users once in a month, for the accounting period to which the specification refers, which is delivered to the address of the Basic User.
10. These Special Terms are an integral part of the Blanket Agreement on Issuing and Using of Diners Club Loyalty Card. All circumstances not covered by these Special Terms shall be regulated by General Terms and Rules of "dinersirano za vas" award programme.
11. These Special Terms shall become effective on 1st February 2017.
